

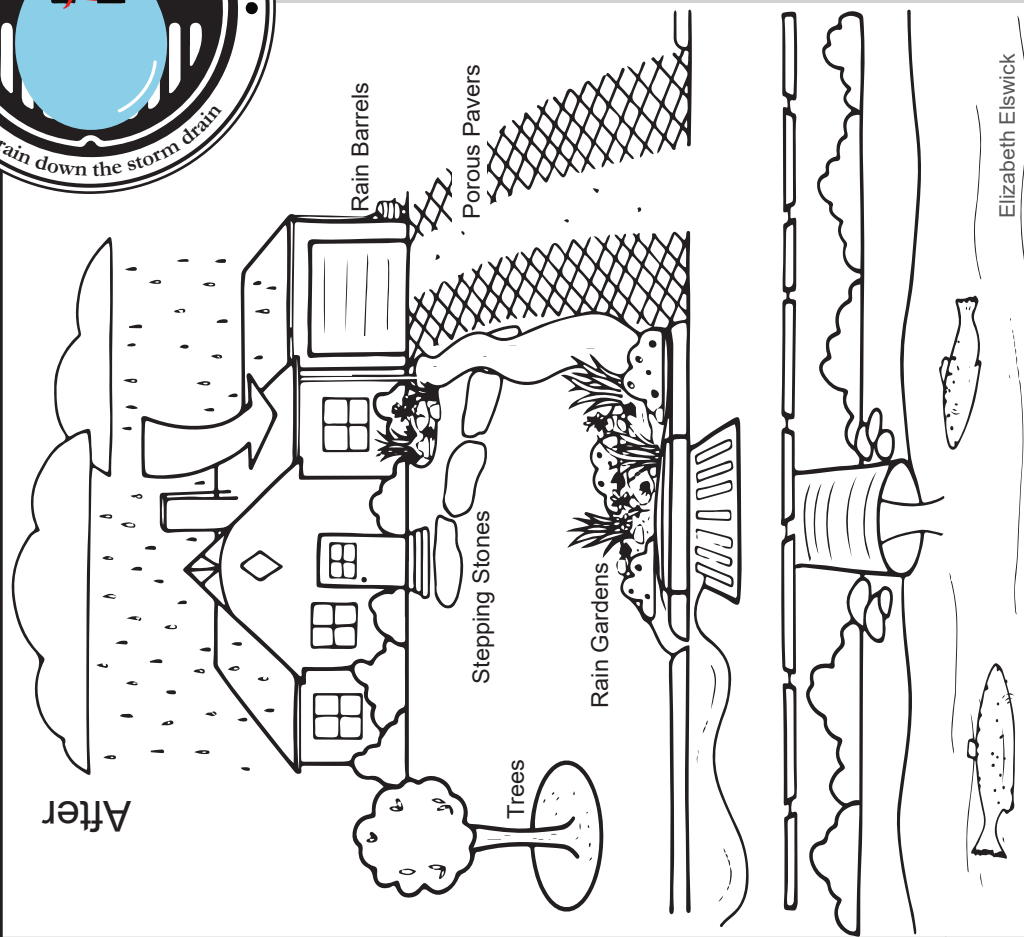
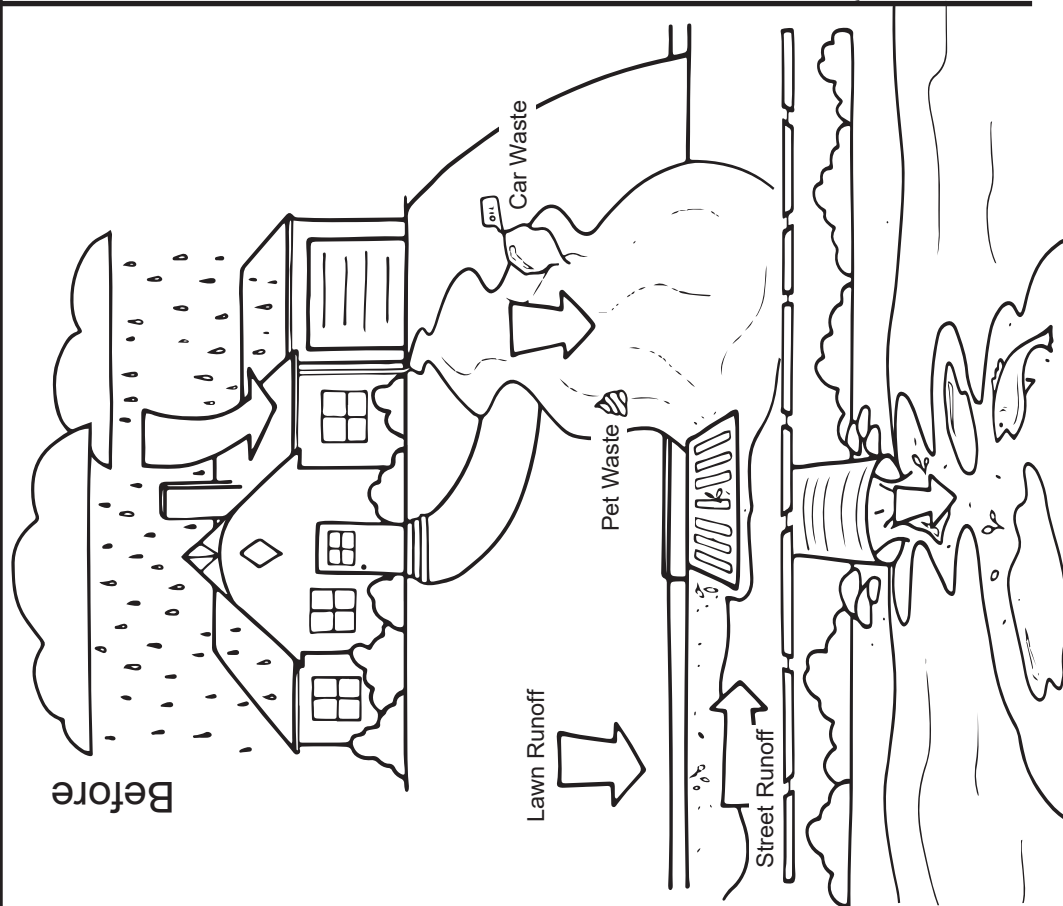

The Advisory Board of the St. Albans Branch Library is proud to present St. Albans Writes...a monthly speaker series featuring local authors. The first speaker is Dr. W. Joseph Wyatt, a 1965 graduate of SAHS. In addition to his op-ed contributions to local papers, Dr. Wyatt, a forensic psychologist and emeritus professor at Marshall University, is the author of The Millennium Man; B. F. Skinner From A to Z , Buckskin Boys: A History of the Buckskin Council . The Breaking Point Killing: True Cases of Murder and Malice, a Forensic Psychologist Remembers. His slide presentation will feature his latest book, The Iraq War, 1998-2018: Quagmire in Babylon. The foreword for this book was written by the author's son, former Marine Daniel Wyatt , and the book includes a number of eloquently authored letters by Daniel Wyatt, who served two tours in Iraq with the United States Marine Corps and is now a lieutenant with the St. Albans Police Department.

## FRIENDLY REMINDER

### FIREWORKS - Ordinance 545.04

When using fireworks in City limits please remember the City Ordinance! To summarize: you must be 18 yrs. or older, not intoxicated, you are responsible for cleaning up debris promptly or for clean up and/or damage costs, you are responsible for fire suppression effort costs, do not use fireworks within 100 ft of any building or structure or within 500 feet of any location posing fire danger like or to a gas station or chemical storage, do not ignite fireworks in/from a vehicle or boat, you must responsibly store fireworks in a safe and secure manner, do not use fireworks during periods of high fire danger or high wind, and you are only permitted to use fireworks between the hours of 11:00 a.m. and 11:00 p.m., on Memorial Day, Independence Day and Labor Day, or between 11:00 am on December 31 and 1:00 am on January 1; however, you may request permission from the Chief of Police to use fireworks for a special event or occasion. **Please see Ordinance 545.04 for full details.**

### GRASS & LEAVES - Ordinance 953.11

No person shall throw, place or scatter any garbage, rubbish, trash, grass clippings, leaves or yard debris or other refuse over or upon any premises, street or alley, sewer or drainage basin, either public or private, or adjacent thereto, and either with or without the intent to later remove or burn the same, or permit from the accumulation of refuse, any premises owned, occupied or controlled by any such person to become or remain offensive, unsanitary, unsightly, unsafe to the public health or a fire hazard.
